**ELIGIBILITY:** All bowlers who are members of the AAUSBC who have rolled a series of three (3) consecutive games in consecutive order in one series, each game being a 200 or more, that series being rolled in a certified league or tournament play and having been rolled on AAUSBC lanes, and said bowler being a bona fide member of the league in which that score was rolled. No pacer or substitute scores shall count. Anyone failing to meet the requirements listed above is ineligible. You may only enter **ONCE**. Each bowler will bowl three games across six lanes. There will be no lighted smoking material allowed on the approaches while either delivering or retrieving a bowling ball. Disqualifications without verbal warning will result if this rule is not adhered to.

**HANDICAP:** Based on 90% of 210 scratch of last season (2008-2009) highest certified league average. If a bowler does not have a 2008-09 season average, he/she must use the highest certified league average as of January 1, 2010 based on a minimum of 21 games. All others will bowl scratch. USBC Rule 319-1-2 (10 pin increase) and Rule 319-3 (reporting tournament prizes) are waived for this tournament. All entrants should familiarize themselves with the rerating requirements set forth by USBC Rule 319-3 and failure to use proper average or make a correction prior to the completion of the first game of the series as set forth by USBC Rule 319-a-3.

Squad Times are 6:00 PM and 9:00 PM on May 17, 18, 19, 20 and 21, 2010. All prepaid reservations will be assured of their first squad choice providing the squad is not full when the reservation is received. Unpaid reservations and walk-ins are subject to lane availability.
